**Explanation of Responses:**

1. Options acquired pursuant to an Agreement and Plan of Merger, dated as of May 16, 2018, by and among the Issuer, Landcadia Merger Sub, Inc., a Delaware corporation ("Merger Sub"), and Waitr Incorporated, a Louisiana corporation ("Waitr"), pursuant to which Waitr merged with and into Merger Sub, with Merger Sub surviving the merger as a wholly owned direct subsidiary of the Issuer. 25% of such options will vest one year from October 1, 2018 (the "Grant Date"), with 1/48 vesting on a monthly basis thereafter. The options will expire 10 years from the Grant Date.
