As of November 30, 2018, Pelham Long/Short Small Cap Master Fund Ltd ("Pelham Small Cap Master") directly held 3,550,000 shares of the Issuer's Common Stock. In addition, as of November 30, 2018, Pelham Small Cap Master directly held 1,921,160 warrants to purchase shares of the Issuer's Common Stock (the "Warrants"). Each Warrant entitles its holder to purchase one-half of one share of Common Stock at an exercise price of \$5.75 per one-half share (\$11.50 per whole share). The Warrants will become exercisable 30 days after the completion of the Issuer's business combination, which took place on November 15, 2018, and will expire five years after such date or earlier upon redemption or liquidation. Pelham Capital Ltd (the "Investment Manager") is the investment manager of Pelham Small Cap Master, and pursuant to an investment management agreement, the Investment Manager has been delegated full voting and investment power over securities of the Issuer held by Pelham Small Cap Master, by both Pelham Small Cap Master and Pelham Capital Management Limited, the manager of Pelham Small Cap Master. Ross Turner, the Chief Investment Officer of the Investment Manager, may be deemed to exercise voting and investment power over securities of the Issuer held by Pelham Small Cap Master.
