- Shares acquired as merger consideration pursuant to an Agreement and Plan of Merger, dated as of May 16, 2018, by and among the Issuer, Landcadia Merger Sub, Inc., a Delaware corporation ("Merger Sub"), and Waitr Incorporated, a Louisiana corporation ("Waitr"), pursuant to which Waitr merged with and into Merger Sub, with Merger Sub surviving the merger as a wholly owned direct subsidiary of the Issuer (the "business combination"). The closing price of the Issuer's common stock was \$11.94 on the effective date of the business combination.
- Shares held of record by Meaux Enterprises, LLC. Mr. Meaux has voting and dispositive control over securities held by Meaux Enterprises, LLC. Mr. Meaux disclaims beneficial ownership of such securities except to the extent of his pecuniary interest therein.
- 250,000 shares of restricted stock subject to the terms of the Waitr Holdings Inc. 2018 Omnibus Incentive Plan, which will vest in three equal installments over a three-year period following the grant date.
